## Sub: <u>Scrutinizer's Report on Postal Ballot conducted as per Section 110 of the Companies</u> Act, 2013 read with the Companies (Management and Administration) Rules, 2014

**Man Infraconstruction Limited** ('the Company') vide resolution by circulation passed by its Board of Directors on September 11, 2023, appointed Mr. Himanshu S. Kamdar (Membership No. FCS 5171), Partner of M/s Rathi & Associates, Practicing Company Secretaries, Mumbai, as the Scrutinizer to ensure that the process of voting by Postal Ballot vide Notice of Postal Ballot dated September 11, 2023 is conducted in the manner prescribed under Section 108 and Section 110 of the Companies Act, 2013 ('the Act') read with the Companies (Management and Administration) Rules, 2014 and the said provisions are duly complied with.

**Resolution No. 1** as a Special Resolution for appointment of Dr. Kshitija Gunwantrao Wadatkar (DIN: 10202871) in the capacity of an Independent Director of the Company for a period of five years with effect from July 25, 2023 upto July 24, 2028, not liable to retire by rotation.

The Company availed the electronic voting platform of National Securities Depository Limited ('NSDL') for providing remote e-voting facility to the members of the Company to vote on the resolution proposed vide Postal Ballot Notice dated September 11, 2023.

The Shareholders were required to complete the postal ballot form and return the same in selfaddressed postage pre-paid envelope to the Scrutinizer so as to reach the Scrutinizer not later than 5.00 P.M. on Tuesday, October 17, 2023 or to cast vote electronically through Remote evoting during the voting period commencing from 09:00 a.m. on Monday, September 18, 2023 upto 05:00 p.m. on Tuesday, October 17, 2023. Accordingly, the Postal Ballot Forms received and e-votes casted upto 05:00 p.m. on Tuesday, October 17, 2023, have been considered for my scrutiny.

A summary of voting through postal ballot forms and remote e-voting with their pattern of voting is as per **Annexure** annexed to this Report.
