SECOND CORRIGENDUM TO THE NOTICE OF THE EXTRA ORDINARY GENERAL MEETING

An Extra Ordinary General Meeting("EGM") of the Shareholders of the Company of Man Infraconstruction Limited ("Company") is scheduled for convening on Saturday, December 23, 2023 at 11:00 A.M.(IST) through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM"). The Notice of the EGM (EGM Notice) dated November 29, 2023 alongwith the Corrigendum dated December 16, 2023 (First corrigendum) was dispatched to the shareholders of the Company in due compliance with the provisions of the Companies Act, 2013, and rules made thereunder, read with circulars issued by Ministry of Corporate Affairs and Securities Exchange Board of India.

The following information in the EGM Notice is hereby notified through this Second Corrigendum to all the shareholders of the Company as two investors, namely (1). Sammys Dreamland Co Pvt Ltd and (2) Mr. Ravindra K Yevale (hereinafter referred to as Proposed investors) whose name is mentioned at Sr. No. 33 and 68 respectively in the table of list of allottees in the EGM Notice dated November 29, 2023 has been disqualified for the present preferential issue/offer due to breach of condition of Regulation 167(6) read with Regulation 159(1) of the SEBI (ICDR) Regulations, 2018. Due to such disqualification, the name of Sammys Dreamland Co Pvt Ltd and Ravindra K Yevale has been removed from the list of proposed allottees, which leads to reduction in the issue size of share warrants.
